A. Roll Call

The meeting commenced at 9:00AM PST.

B. Mission Statement

The mission of the Nevada State Board of Cosmetology is to protect the public health, safety and welfare of those that obtain cosmetology related services through the delivery of quality Testing, Licensing, Inspection and Education Services that focus on consumer protection.

Benita Hollie from Euphoria stated that she was against SB178 as written but does think there might be opportunity to explore alternatives.

D. Agenda Items

1. Review of proposed shampoo/blow dry bill - *For discussion and possible action*

The Board will review and discuss the proposed shampoo/blow dry bill and instruct Executive Director Landry as to whether he is to support or oppose the legislation.

The Board voted to not support SB-178 as written.

Second: Kai Stanton

A second motion was made by Gwen Braimoh who stated that she was open to the idea of a shampoo and blow dry bill but believes any license that would allow for both would need to have substantive training that's comparable to the training and hours in other states that offer similar registrations (Kentucky & Maryland for example).

Board Member Douglass voted in opposition to the second motion.

2. Shampoo/blow dry proposed law change(s) - *For discussion and possible action*

Board will vote on whether to proceed with proposing law changes for shampoo/blow dry registration, to be proposed for the upcoming 2023 legislative session

This agenda item was combined with agenda item #1. No separate vote was taken.

3. Advanced esthetics license - *For discussion and possible action*

Board is to instruct Executive Director Landry to support or oppose an advanced esthetics license bill if it is in alignment with the Board's requirements for licensure.

The Board voted to move forward with the support of an advanced esthetic license in Nevada.
