On March 12, 2021, a revised Roadmap-to Recovery was released by The Nevada Health Response. Page 14 of the Roadmap states that prior to May 1, 2021 hair salons, nail salons, and businesses that provide aesthetic skin services may operate under strict social distancing requirements per existing Directives and protocols. The Roadmap indicates that on May 1, 2021, these facilities must operate in accordance with guidelines from "local authorities".

Board Member Tialutrell McCormick to share information regarding tiered esthetic licenses and provide an overview of current research related to tiered licensing, the process for adopting a tiered licensing system, and potential next steps by the NVBOC in the development of a tiered esthetic system in Nevada.
