CEASE AND DESIST NOTICE

Dear Ms. Gillins,

Be advised that the Nevada State Board of Cosmetology ("Board") has been notified of your unlawful activities in the State of Nevada.

Pursuant to Chapter 644A of the Nevada Revised Statutes ("NRS"), the practice of cosmetology, including the practice of shampoo technology, esthetics, hair design/braiding, and/or nail technology, is subject to the protection and regulation by the State. Further, the State has entrusted the power to regulate and enforce the practice of cosmetology to the Nevada State Board of Cosmetology.

The Board has obtained information that you are operating an unlicensed salon and advertising for and performing esthetic services without being licensed by the State Board of Cosmetology.

Predicated on the aforementioned, **this correspondence shall serve as a demand that Alicia Gillins/dbbeautybar immediately cease and desist from conducting unlicensed activity, namely operating an unlicensed salon, and advertising for and performing esthetic services without being licensed by the Board in the State of Nevada.**

Be advised that NRS 644A.850 authorizes the Board to impose **additional fines of up to \$2,000 per violation** upon any person who violates the provisions of NRS 644A.850, which delineates the grounds for disciplinary action by the Board. Additionally, NRS 644A.950 states that any person who violates any provisions of NRS Chapter 644A is guilty of a misdemeanor. **In the event you fail and refuse to comply with this cease and desist demand, the Board may seek any and all disciplinary action against you.**

This correspondence shall not waive any of the Board's rights and/or remedies, all of which are specifically reserved.

Please review the applicable laws listed below. This action has been based in part on your social media accounts.
