A. Roll Call

Subcommittee Law Review- The subcommittee is to review the following provisions of Chapter 644A of the Nevada Revised Statutes and Nevada Administrative Code to then make recommendations, if any, to the full Nevada State Board of Cosmetology at a future open meeting- for discussion and possible action

1. NRS 644A.505 Duplicate license or certificate of registration; fee.

Bryan Baltazar motioned to keep the verbiage of NRS 644A.505 as is with no changes made.

2. NRS 644A.530 Display of license or certificate of registration.

Bryan Baltazar motioned to move NRS. 644A.530 to Nevada State Board of Cosmetology staff. Staff is to review and develop verbiage to include "Readily Identifiable" and "View of the Public" ensure that it is clear and to also clarify if additional sections need to be added for further clarification. Once this has been completed it is to be presented before the full board in January.

6. NAC 644A.870 Grounds for Disciplinary Action

Matt Brinton motioned to revise/amend NAC 644A.870 to carve out language that would allow for the term "advanced" to be used by those individuals who are licensed, "advanced estheticians" but would prohibit the term "advanced" from being used by licensees in other branches of cosmetology where there is no "advanced" license.

Table a discussion on other qualifying terms in regards to other branches of cosmetology.

Lu Suarez (Euphoria) and Gwen Braimoh (Expertise) expressed their desire to have a meeting to go over possible regulation additions that would supplement the changes SB 291 would be making to NRS 644A and asked that a meeting be held at an early date so that school's interested in offering an advanced esthetic program can gain a better understanding of the new curriculum.

Executive Director Landry noted that he would put together a meeting for schools to ask questions and give input prior to holding a public board meeting where those suggested changes to the NAC would be discussed and voted upon. It was noted that Board decisions and discussion needs to be had at public meetings, but schools are able to meet and give feedback for the Board to discuss at a public meeting. Director Landry stated that staff would gather information related to advanced esthetics to give to the schools during the school meeting to help facilitate conversation and decision making.

F. Comments from Committee Members-for discussion only

Matt Brinton (NIMA) thanked everyone on the call. Subcommittee Member Brinton stated he was looking forward to moving forward with the advanced esthetic curriculum in Nevada and that he would be happy to work with schools and individuals hoping to learn more about advanced esthetics. Subcommittee member Brinton noted that he'd like to move forward with NAC suggestions as they relate to advanced esthetics and SB 291.

Kai Stanton (Subcommittee Chairwoman) thanked everyone who participated in the meeting and stated that she was looking forward to upcoming discussions.
