

EFFECTIVE 10.1.2023

Senate Bill 249 will go into effect on 10.1.2023.

The chart below breaks down some of the most common services for an esthetician and an advanced esthetician and also outlines prohibited/ out-of-scope services.

All nonablative procedures require the supervision of a healthcare professional (Physician, Physician's Assistant or Advanced Practice Registered Nurse).
