3. Carpeting is permitted only within the driving or cab area, if applicable, and only if approved by the appropriate city and county agencies governing fire codes.
4. All storage cabinets must be secured by the use of spring struts or friction catches.
5. All equipment must be securely anchored to the establishment.
6. The interior of the establishment must be 7 to 8 feet wide, inclusive, have a ceiling height of at least 6 feet and be at least 24 feet long, as measured from the front interior wall to the back of the establishment.
7. One 5-pound ABC fire extinguisher must be mounted in public view.
8. A ramp or lift must be provided for access to the establishment if services are provided to persons with disabilities.
9. No services may be performed while the establishment is in motion.

11. Containers in the establishment must consist of galvanized stainless steel or other noncorrosive material not including glass.
12. All chemicals in the establishment must be stored in secured cabinets, separate and apart from other articles or equipment in the establishment.

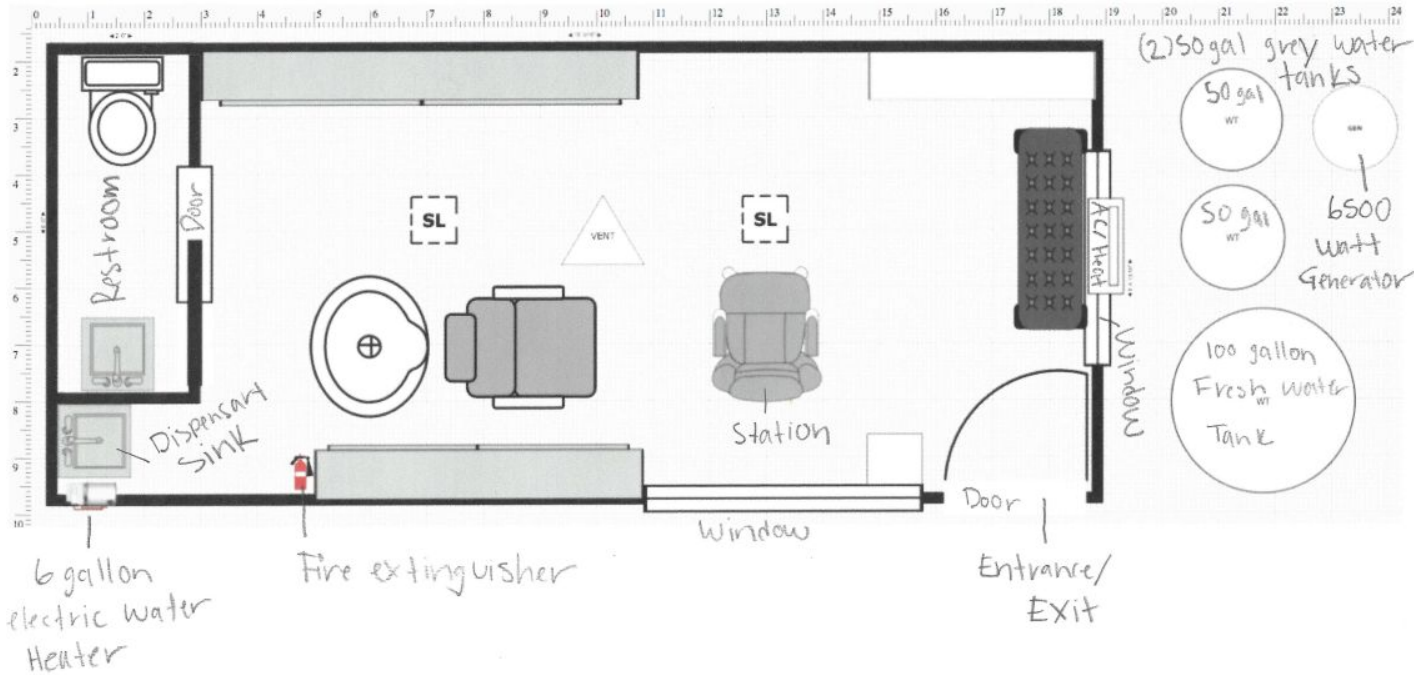

Each cosmetological establishment or school of cosmetology must have suitable permanent plumbing which provides an adequate and readily available supply of hot and cold running water at all times and is permanently connected for drainage of sewage and potable water within the areas where work is performed and supplies dispensed.
2. Each cosmetological establishment or school of cosmetology must contain a dispensary sink.
3. The floor coverings within a distance from all exposed sides of a sink, pedicure spa or dispensary sink that is the same distance as the width of the sink, pedicure spa or dispensary sink must be made of a washable material which is not porous or absorbent.

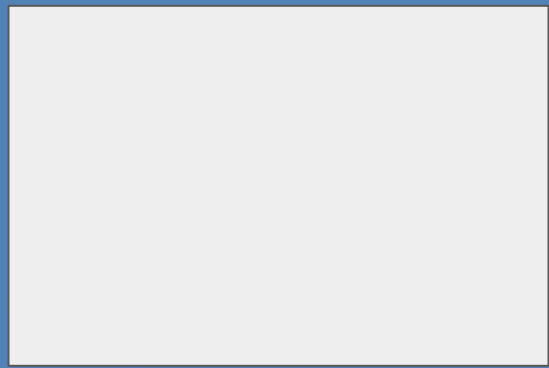

REVISER'S NOTE.

Ch. 415, Stats. 2021, the source of this section, contains the following provision not included in NRS:

"Sec. 45. 1. Notwithstanding the amendatory provisions of this act, the Board may issue a license as an advanced esthetician to an applicant, without regard to whether the applicant meets the requirements set forth in the amendatory provisions of this act, if the applicant:

- (a) Holds a current license as an esthetician issued by the Board on or before October 1, 2023;
- (b) Applies to the Board for a license as an advanced esthetician on or before October 1, 2023; and
- (c) Has:

(1) Continuously held a license as an instructor of estheticians issued by the Board for not less than 3 years immediately preceding the submission of the application for a license; or

(2) Completed at least 75 hours of training in the operation of lasers for medical or esthetic purposes or at least 150 hours of practical experience as an operator of lasers for medical or esthetic purposes under the delegation or supervision of a health care professional or other licensed professional whose licensure permits such delegation or supervision.

2. An applicant who applies for a license from the Board pursuant to subsection 1 must submit to the Board:

- (a) A completed application on a form prescribed by the Board;
- (b) The fee for the initial issuance of a license as an advanced esthetician set forth in NRS 644A.490, as amended by section 34 of this act;
- (c) Proof satisfactory to the Board that the applicant satisfies the requirements for licensure set forth in subsection 1; and
- (d) Any other information requested by the Board.

3. A license issued by the Board pursuant to subsection 1 shall be deemed to be a license as an advanced esthetician issued by the Board pursuant to NRS 644A.490, as amended by section 34 of this act.

4. As used in this section:

- (a) "Advanced esthetician" has the meaning ascribed to it in section 7 of this act [NRS 644A.013].
- (b) "Board" means the State Board of Cosmetology.
- (c) "Esthetics" has the meaning ascribed to it in NRS 644A.075.
- (d) "Health care professional" has the meaning ascribed to it in NRS 453C.030.

Advanced Esthetician: Acknowledgement of Policies & Responsibilities

On January 1, 2022 Senate Bill 291 went into effect. Senate Bill 291 created a new licensing type: advanced esthetician. As per the Bill, the scope of practice for an advanced esthetician includes but is not limited to exfoliation, microdermabrasion, microneedling, dermaplanning, extractions, hydrotherapy and nonablative, esthetic medical procedures. Advanced esthetics includes the scope of practice of esthetics as defined in NRS 644A.075. It's the responsibility of the Advanced Esthetician to notify the Board immediately if s/he begins offering advanced esthetic services that require the supervision of a health care professional. Advanced esthetic services that require the oversight of a health care professional may not, in any circumstances, be performed without such oversight.

Per Board policy, an Advanced Esthetician shall immediately notify the Board, in writing, after any change relating to the supervision of advanced esthetic services. Such changes may include but are not limited to a permanent or temporary change of the overseeing health care professional, or the commencement or termination of the supervisory relationship with the health care professional.

Dear LOREATHA L MCGEE,

Be advised that the Nevada State Board of Cosmetology ("Board") has been notified of your unlawful activities in the State of Nevada.

Pursuant to Chapter 644A of the Nevada Revised Statutes ("NRS"), the practice of cosmetology, including the practice of shampoo technology, esthetics, advanced esthetics, hair design/braiding, and/or nail technology, is subject to the protection and regulation by the State. Further, the State has entrusted the power to regulate and enforce the practice of cosmetology to the Nevada State Board of Cosmetology.

Chapter 644 of the Nevada Revised Statutes and Nevada Administrative Code regulates the practice of Cosmetology and all the branches thereof. The State of Nevada requires any cosmetology service (or branch thereof) be performed by a licensed individual and only inside a licensed establishment. By offering, advertising, or providing any cosmetology services without proper licensing, you are not in compliance with these provisions.

Predicated on the aforementioned, this correspondence shall serve as a demand that LOREATHA L MCGEE immediately cease and desist from offering, advertising, or providing any esthetic services in a location not licensed by the Board, practicing advanced esthetics without a license, and operating a salon establishment without being licensed by the Board.

Prohibited Acts

NRS 644A.900 Unlawful practices without license or certificate of registration; exceptions.

1. It is unlawful for any person to conduct or operate a cosmetological establishment, an establishment for hair braiding, a school of cosmetology, or any other place of business in which any one or any combination of the occupations of cosmetology are taught or practiced unless the person is licensed in accordance with the provisions of this chapter.
2. Except as otherwise provided in subsections 4 and 5, it is unlawful for any person to engage in, or attempt to engage in, the practice of cosmetology or any branch thereof, whether for compensation or otherwise, unless the person is licensed or registered in accordance with the provisions of this chapter.

NRS 644A.950 Penalties.

1. Every person violating any of the provisions of this chapter shall be guilty of a misdemeanor.
2. Every person required by the provisions of this chapter to perform any act or duty who shall fail, refuse or neglect to perform the duty in the manner directed by the provisions of this chapter shall be guilty of a misdemeanor.
3. Every person required by the provisions of this chapter to perform any duty at a specified time or in a specified manner who shall fail, refuse or neglect to perform the duty at the time and in the manner provided by the terms of this chapter shall be guilty of a misdemeanor.

NRS 644A.955 Additional penalties for person who engages in certain conduct without license or registration; authority of Board to issue citations and orders to cease and desist; administrative fines; appeals.

1. In addition to any other penalty:
 - (a) **The Board may issue a citation to a person who violates the provisions of NRS 644A.900.** A citation issued pursuant to this paragraph must be in writing and describe with particularity the nature of the violation. The citation also must inform the person of the provisions of subsection 2. A separate citation must be issued for each violation. If appropriate, the citation may contain an order to cease and desist.
 - (b) Upon finding that a person has violated the provisions of NRS 644A.900, the Board shall assess an administrative fine of:

(1) For the first violation, \$1,000.

(2) For the second violation, \$1,500.

(3) For the third or subsequent violation, \$2,000.

2. To appeal a finding of a violation of NRS 644A.900, the person must request a hearing by written notice of appeal to the Board within 30 days after the date on which the citation is issued.



Advanced Esthetician: Acknowledgement of Policies & Responsibilities

On January 1, 2022 Senate Bill 291 went into effect. Senate Bill 291 created a new licensing type: advanced esthetician. As per the Bill, the scope of practice for an advanced esthetician includes but is not limited to exfoliation, microdermabrasion, microneedling, dermaplaning, extractions, hydrotherapy and nonablative, esthetic medical procedures. Advanced esthetics includes the scope of practice of esthetics as defined in NRS 644A.075. It's the responsibility of the Advanced Esthetician to notify the Board immediately if s/he begins offering advanced esthetic services that require the supervision of a health care professional. Advanced esthetic services that require the oversight of a health care professional may not, in any circumstances, be performed without such oversight.

Per Board policy, an Advanced Esthetician shall immediately notify the Board, in writing, after any change relating to the supervision of advanced esthetic services. Such changes may include but are not limited to a permanent or temporary change of the overseeing health care professional, or the commencement or termination of the supervisory relationship with the health care professional.

I understand that under no circumstances shall an advanced esthetician perform any ablative esthetic medical procedure. An ablative medical procedure means an esthetic medical procedure that is expected to excise (remove by cutting), vaporize, disintegrate or remove living tissue.

LM (Licensee Initials)

I understand that an advanced esthetician may only perform a non ablative procedure under the supervision of a health care professional. Supervising health care professionals will be required to execute a "Collaboration with Advanced Esthetician" acknowledgment form for each Advanced Esthetician s/he is supervising.

LM (Licensee Initials)

I understand that a health care professional is defined in NRS 453C.030 and includes: advanced practice registered nurses, physicians and physician assistants.

LM (Licensee Initials)

I understand that physical supervision requires the health care professional be:

1. Readily available for immediately consultation with the advanced esthetician by phone or other communication technology which allows the health care professional and advanced esthetician to communicate in real time AND
2. Remains within 60 miles or 60 minutes of the location at which the procedure is being performed and is readily available to provide in-person care if any problems arise during the procedure.

LM (Licensee Initials)

I understand the scope of practice of an Advanced Esthetician includes only those services which are performed for esthetic purposes and does not include the treatment of medical, physical or mental ailments.

LM Licensee Initials

I understand that an advanced esthetician licensed by the Board may only practice in a licensed cosmetological establishment. It's possible that an establishment where cosmetology services are performed may be required to hold more than one license from more than one licensing body. It is the responsibility of the licensee to ensure that s/he is practicing in a location that is licensed by the Board.

LM (Licensee Initials)

I understand that all Board licensees have a responsibility to perform services in a safe and sanitary manner. Licensees have a responsibility to refuse service whenever a service cannot be performed safely.

LM (Licensee Initials)

I understand that this document as well as other documents, federal and state laws and regulations governing the practice of advanced esthetics are subject to change. I also understand that it is the responsibility of the licensee to remain in compliance with the rules and regulations of Chapter 644A of the NRS and NAC and SB 291, including changes made after the initial license is granted.
