Per the Governor, requirements and restrictions due to Covid-19 for salon businesses are under the authority of your local county jurisdiction starting May 1, 2021. The Board of Cosmetology **does not** have the discretion to modify or ease county-imposed requirements and/or mandates as authority has been granted to local jurisdictions, not the Board of Cosmetology. Please contact your local county government to inquire about restrictions and requirements starting May 1, 2021.

Per the Governor, masks are required for clients, customers, stylists, technicians, and other employees. The mask mandate is **statewide** and will remain a requirement at this time. Counties **cannot** override the statewide mask mandate. The Board of Cosmetology does not have the discretion to modify or ease a statewide mask mandate. Per the Governor, this measure will remain in place to protect the health and safety of Nevadans and help get the state to a full reopening.
