- 3. Reading of the Board of Cosmetology Mission Statement.
- 4. Comments by General Public. Members of the public will be invited to speak before the Board; however, no action may be taken on a matter during public comment until the matter itself has been included on an agenda. Prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the Board may refuse to consider public comment. See NRS 233B.126. Public comment may be limited to three minutes per person at the discretion of the chairperson. (NRS 241.020)
- 5. <u>Consideration and Approval of Minutes:</u>The Board will discuss and possibly approve the minutes from the April 9, 2018 Board meeting. (For possible action).
- 6. <u>Complaint Hearing:</u> NSBOC (Case#C-2017-0595) vs Ally's Beauty Salon (S-10505), Mirna Lainez ,Owner. Formal disciplinary hearing to determine whether grounds for discipline exist pursuant to violations of NRS 644.430(1)(a)and/or NRS 644.360(2) (employing unlicensed individuals). (For possible action).
- 7. Complaint Hearing: NSBOC (Case#C-2017-0642) vs Trinity Salon & Spa (S-12189), Jocelyn McCall, Owner. Formal disciplinary hearing to determine whether grounds for discipline exist pursuant to violations of NRS 644.350 (Failure to timely pay renewal fees). (For possible action).
- 8. <u>Discussion</u>: The Board will discuss and possibly vote on a proposed change to Nevada Revised Statutes Chapter 644A.330(5)(a) and NRS 644A.330(5)(c) submitted from the Law Review Subcommittee. The committee recommends lowering the esthetician qualifications for examination hours from 900 to 600, and for esthetician apprentice hours from 1800 to 1200. Public comments allowed. (For possible action)
- 9. <u>Discussion</u>: The Board will discuss and possibly vote on a proposed change to Nevada Revised Statutes Chapter 644A.315(5)(b) and NRS 644A.315(5)(b) submitted from the Law Review Subcommittee. The committee recommends lowering the hair designer qualifications for examination hours from 1200 to 1000, and for hair designer Apprentice from 2400 to 2000 hours. Public comments allowed. (For possible action).
- 10. <u>Discussion</u>: The Board will discuss and possibly vote on a proposed change to Nevada Revised Statutes Chapter 644A.075(1)(b) submitted from the Law Review Subcommittee. The committee suggested adding "eyelash extensions" and "eyelash perming" to "Esthetics" defined. Public comments allowed. (For possible action).
- 11. <u>Discussion</u>: The Board will discuss and possibly vote on a proposed change to Nevada

Revised Statutes Chapter 644A.520(5) submitted from the Law Review Sub Committee. The committee suggested adding two (2) continuing education units (CEU's) as a requirement for all licensees at each renewal period. These would be in addition to the current four (4) hours of instruction relating to infection control and prevention. Public comments allowed. (For possible action).

- 12. <u>Discussion:</u> The Board will discuss and possibly vote on a proposed change to Nevada Revised Statutes Chapter 644A.600(2) submitted from the inspection team. The team suggested a change in the requirements for application for a Cosmetological Establishment. Public comments allowed. (For possible action).
- 13. <u>Discussion:</u> The Board will discuss and possibly vote on a proposed change to Nevada Revised Statutes Chapter 644A.030(1)(d) submitted from the inspection team. The team suggested removing a line from the scope of practice for a cosmetologist. Public comments allowed. (For possible action).
- 14. <u>Petition to Appear</u>: Victor Cortez, Owner of Exquisite Nails & Spa (S-186711) is appealing violations that were issued pursuant to NRS 644.190.2 (individuals practicing without a license). (For possible action).
- 15. <u>Petition to Appear</u>: Alda Rodriguez (C-18386) Owner of Victoria's Beauty Salon (S-10267) is appealing Citation # 5476 pursuant to NRS 644.360 (2) (allowing a licensee to work with an expired license) and Citation #5478 pursuant to NRS 644.350 (operating a salon with an expired license).
