3. Reading of the Board of Cosmetology Mission Statement.

5. Review and possibly formulate revisions for submission to the legislature to NRS 644.408 "Amount of instruction required before student commences work on public." This statute may be revised to require a percentage of hours instead of a total number of hours. (for Possible Action)
6. Review and possibly formulate revisions for submission to the legislature to NRS 644.120 "Regulations governing sanitary conditions." This statute may be revised to state mandatory hot and cold running water. (for Possible Action)
7. Review and possibly formulate revisions for submission to the legislature to NRS 644.320 "Expiration of license or certificate of registration; fee for initial license or certificate of registration; deferral of expiration in certain circumstances; regulations." This may be changed to requiring continuing Education courses prior to renewal for all licensees. (for Possible Action)
8. Review and possibly formulate revisions for submission to the legislature to NRS 644.095 "Ban on use of device in practice of cosmetology; banned devices prohibited within certain areas of cosmetological establishment; regulations." This item might need to specify the actual allowable strength of formaldehyde use. (for Possible Action)
9. Review and possibly formulate revisions for submission to the legislature to NRS 644.193. "Instructors: Qualifications for provisional license; fee; expiration and extension of provisional license." This revision could consider an adjustment and/or a reduction of the hours required. (for Possible Action)
10. Review and possibly formulate revisions for submission to the legislature to NRS 644.0207 "Aesthetics" defined." This definition may be enhanced. (for Possible Action)

11. Review and possibly formulate revisions for submission to the legislature to NRS 644.478 "Unlawful advertising relating to education, licensing or practice of cosmetology or threading." This definition may be revised to include a more Detailed scope of practice for procedures relating to eyelashes (perming/tinting/ technique/disinfection). (for Possible Action)
12. Discussion on how to advise salon owners regarding the Federal Labor Standards Act (FLSA). This federal act establishes wage and labor standards affecting full-time and part-time workers in the private sector and in government. (for Possible Action)
13. Comments by Committee Members. Future agenda items for discussion on Chapter 644 of the Nevada Revised Statutes (NRS 644)
