**Suggestion:** Restriction on strength of formaldehyde

**Suggestion:** Consider adjusting the hours required

Federal Labor Standards Act

**Suggestion:** Advise salons about this wage and hour law and possibly define FLSA in cosmetology law about the difference of being an employee or an independent contractor

NRS 644.478 Unlawful advertising relating to licensing

**Suggestion:** Define the scope of practice for all procedures relating to eyelashes (perming/tinting/technique/disinfection)
