

Be advised that the Nevada State Board of Cosmetology ("Board") has been notified of your unlawful activities in the State of Nevada.

Pursuant to Chapter 644A of the Nevada Revised Statutes ("NRS"), the practice of cosmetology, including the practice of shampoo technology, esthetics, advanced esthetics, hair design/braiding, and/or nail technology, is subject to the protection and regulation by the State. Further, the State has entrusted the power to regulate and enforce the practice of cosmetology to the Nevada State Board of Cosmetology.

The Board has obtained information that you are engaged in the practice of teaching esthetician services and operating a salon without being licensed to do so. Chapter 644 of the Nevada Revised Statutes and Nevada Administrative Code regulates the practice of Cosmetology and the branches thereof. The State of Nevada requires esthetician services and classes to be performed by a licensed individual and in a licensed establishment. By teaching and performing esthetic services inside your home without proper licensing, you are not in compliance with these provisions.

Predicated on the aforementioned, this correspondence shall serve as a demand that Jasmine Busch immediately cease and desist from performing any esthetician services and operating a salon, without being licensed in the State of Nevada.

Be advised that NRS 644A.850 authorizes the Board to impose additional fines of up to \$2,000 per violation upon any person who violates the provisions of NRS 644A.850, which delineates the grounds for disciplinary action by the Board. Additionally, NRS 644A.950 states that any person who violates any provisions of NRS Chapter 644A is guilty of a misdemeanor. In the event you fail and refuse to comply with this cease and desist demand, the Board may seek any and all disciplinary action against you.

PROHIBITED ACTS; PENALTIES; ENFORCEMENT

Prohibited Acts

NRS 644A.900 Unlawful practices without license or certificate of registration; exceptions.

1. It is unlawful for any person to conduct or operate a cosmetological establishment, an establishment for hair braiding, a school of cosmetology, or any other place of business in which any one or any combination of the occupations of cosmetology are taught or practiced unless the person is licensed in accordance with the provisions of this chapter.
2. Except as otherwise provided in subsections 4 and 5, it is unlawful for any person to engage in, or attempt to engage in, the practice of cosmetology or any branch thereof, whether for compensation or otherwise, unless the person is licensed or registered in accordance with the provisions of this chapter.

NRS 644A.950 Penalties.

1. Every person violating any of the provisions of this chapter shall be guilty of a misdemeanor.
2. Every person required by the provisions of this chapter to perform any act or duty who shall fail, refuse or neglect to perform the duty in the manner directed by the provisions of this chapter shall be guilty of a misdemeanor.
3. Every person required by the provisions of this chapter to perform any duty at a specified time or in a specified manner who shall fail, refuse or neglect to perform the duty at the time and in the manner provided by the terms of this chapter shall be guilty of a misdemeanor.

NRS 644A.955 Additional penalties for person who engages in certain conduct without license or registration; authority of Board to issue citations and orders to cease and desist; administrative fines; appeals.

1. In addition to any other penalty:
 - (a) The Board may issue a citation to a person who violates the provisions of NRS 644A.900. A citation issued pursuant to this paragraph must be in writing and describe with particularity the nature of the violation. The citation also must inform the person of the provisions of subsection 2. A separate citation must be issued for each violation. If appropriate, the citation may contain an order to cease and desist.
 - (b) Upon finding that a person has violated the provisions of NRS 644A.900, the Board shall assess an administrative fine of:
 - (1) For the first violation, \$1,000.
 - (2) For the second violation, \$1,500.
 - (3) For the third or subsequent violation, \$2,000.
2. To appeal a finding of a violation of NRS 644A.900, the person must request a hearing by written notice of appeal to the Board within 30 days after the date on which the citation is issued.

If appropriate, the citation may contain an order to cease and desist. (b) Upon finding that a person has violated the provisions of NRS 644A.900, the Board shall assess an administrative fine of:

- (1) **For the first violation, \$1,000.**
- (2) **For the second violation, \$1,500.**
- (3) **For the third or subsequent violation, \$2,000.**

2. To appeal a finding of a violation of NRS 644A.900, the person must request a hearing by written notice of appeal to the Board within 30 days after the date on which the citation is issued.

I'm writing in regards to the cease and desist notices and fines dated 4/18/22 and 4/28/22. Prior to these notices I had no knowledge that I could not do nails without a license. It was my understanding that in order to be employed at a salon you must be licensed. I haven't been doing any nails for sometime now since I have been working 2 jobs since the end of 2021. I believe the anonymous person who notified you was someone that I had an altercation with in Newport over a stolen laptop from our vacation home. It's the only thing that makes sense. At the same time someone also hacked my Instagram account which I locked it and made it unaccessible to me.

I called the office on West Russell to try to resolve this. I was told that after the cease and desist dated 4/18 that I continued to do nails, which is untrue. I then explained what happened and was told that it's not the first time they heard this

story. I said moving forward from here how do I protect myself from future fines if this fine is unwarranted as I haven't done anyones nails since the date of the first cease and desist and for quite sometime prior? She said they thoroughly investigate, which can't be the case since I haven't been doing nails. I also asked for proof from the investigation and she said she can't give it to me.

I admit that I made a mistake. I taught myself to do my nails during the shut down which turned into me doing my friends nails. I was in high school, I was in no way running a business from the house. I haven't done anyones nails including my own for a while now. And I did not violate the Cease and desist dated 4/18/22. I'm hoping to get the fine dropped and to learn how to protect myself moving forward.

Ms. Mugleston came in to Bazaar inquiring station rental in 2020, she informed me she was currently licensing in Utah and the state board allowed them to work few hours a day in Nevada, I told her I will look into the law, then pandemic happened and I didn't heard from her until this January 2022, she came in and wanting to rent the station as a drop in stylist, but I told her she will have to transfer her license before can start working in here.

On the date of the incident, she came in to the salon unannounced and uninvited without asking for my permission first. Since she did not have a key and I was not there, one of the renters thought she was our new drop in stylists so she opened the door for her without knowing she was illegally trespassing. After I received the violation email I tried to contact her but she never answer my calls and even blocked my number.

At Bazaar all renters will have to sign an agreements and contract before start working at salon, for Drop in stylists they only pay \$45 a day to use the station, is not worth it for me to risk getting fine for \$1000 allowing none license people working at the salon. I've provided in the attachment agreements that my renters signed before they start.

While I acknowledge there are opportunities for me to improve on the safety of the operation of the salon in the future which I am actively pursuing as we speak, I do not believe I should be held liable for the reckless action of a rogue individual. Therefore, I plead for your kind consideration to dismiss this case against the studio.

and teach people about eyelash extensions.

Then, on April 27th 2022, I went personally to the Nevada State Board of Cosmetology and talked to one of your associates, I asked what I should do now, etc., after which I received an invoice for payment dated April 28th 2022 in the amount of \$1100. During my conversation with your associate, I didn't say that I was going to continue teaching or anything like that. I fully agreed with all the requirements and laws of the State of Nevada, but nevertheless, I received a bill.

My mistake was that when I moved during the pandemic in March 2020 from another state, I did not contact the Nevada State Board of Cosmetology again. I tried to do this, but at that time all government organizations did not work due to the Covid virus.

There were other lash artists in the salon where I rented a room, and one of them taught people how to do eyelash extensions, which showed me that this was apparently acceptable.

And I also did some extended research and found at least 13-15 individuals and salon owners in Las Vegas who doing this activity constantly (teaching people how to make eyelash extensions).

It gave me confidence, unfortunately, which means I can do it too.

I am not a bad person and I respect the laws of the country very much. I strive to help people and the community where I live in whatever way I can. When I moved in 2020 and there was chaos around the world and there were so many people in the country in need of help, I made a donation to Summerlin Hospital. I collected all the disposable stuff, and masks and also bought hand sanitizers with almost the last money and took them to the hospital because I felt that if you can, you should help.

Although I, like everyone else then, experienced big financial suffering. And even if I see homeless people on the street, I give them at least some money for food (the last time it was on July 6th, I gave a homeless man \$30 and water).

I am a single mom and I am raising my son, he is 7 years old, and my mother is also on my full support, she is 71 years old and she has dementia. My right hand can no longer function as it used to (carpal tunnel syndrome) and therefore all these factors have played a role in the fact that I cannot work now. I was unable to renew my esthetician license due to financial issues.

Yesterday was the last due date for payment of this fine in the amount of \$1100. I did not forget about it, I just tried to find money to pay, but I couldn't.

Now I have \$1,322.45 and this is my last money (2 credit cards).

If required I can send screenshots of my credit cards financial statements. My rent for the apartment is \$1,557 and is due August 1st.

I'm completely broken.

I also do not disclaim responsibility and fully understand that every action has consequences.

I'm asking you leniently to find so way for canceling this fine on the basis that I have not posted anything on social media since April 2nd 2022, nor have I deled anything and I also haven't done any teaching activity since 2021.

I can prove it if you need it by contacting Instagram and emailing them from the Nevada State Board of Cosmetology all papers that I received, I think they will provide a report on my social media activity.

I can volunteer for you or do any other community work. I do not waive my responsibility and respect any of your decisions.

Except as otherwise provided in subsections 4 and 5, it is unlawful for any person to engage in, or attempt to engage in, the practice of cosmetology or any branch thereof, whether for compensation or otherwise, unless the person is licensed or registered in accordance with the provisions of this chapter.

NRS 644A.950 Penalties.

1. Every person violating any of the provisions of this chapter shall be guilty of a misdemeanor.
2. Every person required by the provisions of this chapter to perform any act or duty who shall fail, refuse or neglect to perform the duty in the manner directed by the provisions of this chapter shall be guilty of a misdemeanor.
3. Every person required by the provisions of this chapter to perform any duty at a specified time or in a specified manner who shall fail, refuse or neglect to perform the duty at the time and in the manner provided by the terms of this chapter shall be guilty of a misdemeanor.

NRS 644A.955 Additional penalties for person who engages in certain conduct without license or registration; authority of Board to issue citations and orders to cease and desist; administrative fines; appeals.

1. In addition to any other penalty:

(a) **The Board may issue a citation to a person who violates the provisions of NRS 644A.900.** A citation issued pursuant to this paragraph must be in writing and describe with particularity the nature of the violation. The citation also must inform the person of the provisions of subsection 2. A separate citation must be issued for each violation. If appropriate, the citation may contain an order to cease and desist. (b) Upon finding that a person has violated the provisions of NRS 644A.900, the Board shall assess an administrative fine of:

- (1) **For the first violation, \$1,000.**
- (2) **For the second violation, \$1,500.**
- (3) **For the third or subsequent violation, \$2,000.**

2. To appeal a finding of a violation of NRS 644A.900, the person must request a hearing by written notice of appeal to the Board within 30 days after the date on which the citation is issued.


I am writing this notice to Appeal and request a Waiver of ALL amounts owing to the Board. Information obtained by your office from Fairways at Southern Highlands Parkway Management was not fully relayed to the board. In March yes, I received a notice from the management office to cease all activities being conducted in the apartment and was given a 5 days' notice to cure. I complied with this notice and CEASED all activities IMMEDIATELY as I did not and could not afford to be evicted. The 5 days had past however Management did not come into the residence to confirm that the violation was cured. After several attempts to obtain a date from management on the inspection, we instead received on 03/16/2022 a 3-day EVICTION notice. I was terribly upset as the violation was immediately CURED, as informed to do so. This has put me and my family in a very tough situation. My 77year old grandfather only had a matter of days to obtain a new residence and spent thousands of dollars to have us relocated to a new home in 3 days. I apologize for not knowing the rules and regulations set forth by the State of Nevada as I am from Hawaii. It was a lesson learned and one well taken.

I have since educated myself on conducting business in Nevada and after settling into our new home and readjusting to life and everything we endured because of this situation, I enrolled myself into school at **G Skin and Beauty Institute** and have currently been attending Full-Time since **April 25th, 2022**, with my graduation date set for **09/17/2022**. I have also applied for my LLC and Business License, please rest assure I have not done any lashes since given the notice from our previous Management company and to ensure compliance with Nevada State Law. I am going to school now and doing everything the correct way as I refuse to endure going through a nightmare like this again.

I just recently received letters all together in 1 envelope from your office stating I owe \$5200.00 in fines. With all due respect, I was not aware of any of these notices as you can see, we moved in March and all notices were addressed to the old address. I am asking for a waiver of these fines as all activities were stopped in March prior to being evicted on 03/16/2022, unit was vacated, and keys turned over to Management. Our new lease started at the new residence on 03/20/2022.

I am not capable of paying such a big fine which I had no knowledge about, since I am a Full -Time student with no income. I am looking forward to graduating so I can be a Licensed Esthetician and being able to take my exam with the board. I humbly ask for a waiver of these fines as I have no means of paying them as I also had to make arrangements on my tuition as well. Prohibited Acts

NRS 644A.900 Unlawful practices without license or certificate of registration; exceptions.

3. Every person required by the provisions of this chapter to perform any duty at a specified time or in a specified manner who shall fail, refuse or neglect to perform the duty at the time and in the manner provided by the terms of this chapter shall be guilty of a misdemeanor.

NRS 644A.955 Additional penalties for person who engages in certain conduct without license or registration; authority of Board to issue citations and orders to cease and desist; administrative fines; appeals.

1. In addition to any other penalty:
 - (a) The Board may issue a citation to a person who violates the provisions of NRS 644A.900. A citation issued pursuant to this paragraph must be in writing and describe with particularity the nature of the violation. The citation also must inform the person of the provisions of subsection 2. A separate citation must be issued for each violation. If appropriate, the citation may contain an order to cease and desist.
 - (b) Upon finding that a person has violated the provisions of NRS 644A.900, the Board shall assess an administrative fine of:

 - (3) For the third or subsequent violation, \$2,000.
2. To appeal a finding of a violation of NRS 644A.900, the person must request a hearing by written notice of appeal to the Board within 30 days after the date on which the citation is issued.

Be advised that the Nevada State Board of Cosmetology ("Board") has been notified of your unlawful activities in the State of Nevada.

Pursuant to Chapter 644A of the Nevada Revised Statutes ("NRS"), the practice of cosmetology, including the practice of shampoo technology, esthetics, advanced esthetics, hair design/braiding, and/or nail technology, is subject to the protection and regulation by the State. Further, the State has entrusted the power to regulate and enforce the practice of cosmetology to the Nevada State Board of Cosmetology.
