The purpose of the workshop was to solicit comments from interested persons on the Proposed regulation in Chapter 644 of the State Board of Cosmetology.

In accordance with NRS Chapter 241, notice of this workshop was posted on Monday, July 6, 2015 at each of the Board of Cosmetology offices, the Board of Cosmetology website, the State of Nevada website, the Legislative Counsel Bureau website, the Attorney General's office, all Nevada State schools of cosmetology, as well as libraries in different counties throughout the State.

The meeting was called to order at 9:04 a.m.

1. Call to Order/Roll Call

2. The Pledge of Allegiance

3. Reading of the Board of Cosmetology Mission Statement.

4. Comments by General Public

The Public consisted of representatives from several Southern and Northern Nevada Schools. There were NO public comments offered.

Mr. Landry reviewed all sections of the proposed regulation changes, giving an explanation of the purpose for the amendment, adoption and/or repeal of the specific regulations pertaining to chapter 644 of the Nevada Administrative Code.

- 5. Proposed regulation required by the passage of AB-246 relating to the newly created Shampoo Technologist registration.
- 6. Proposed regulation required by the passage of AB-246 relating to schools of Cosmetology. These include the reduction of hours from 1800 to 1600 for cosmetologist education; the change in square footage and minimum student requirement; and the change in Instructor requirements.
- 7. Proposed regulation required by the passage of AB-246 relating to the ADA's definition of a service animal.
- 8. Proposed regulation required by the passage of AB-246 requiring the Board to Inspect Threading establishments and provide a fee for Threader registration
- 9. Proposed regulation required by the passage of AB-246 for consistency in the law for Hair Braiders as all other branches of cosmetology for proof of age and testing verbiage.
- 10.Proposed regulation required by the passage of AB-246 requiring changes for Barbers. These include increasing 400 hours to 600 hours for a Barber to Become a Cosmetologist; decreasing 400 hours to 0 hours for a Barber to become a Hair Designer; and for Nail Technologist working within a Barber Shop to have a separation of work area.

Meeting for Public Hearing on this regulation will be scheduled. The Board of Cosmetology will consider fully all public comment and discuss and determine whether to adopt these new regulations or changes to existing regulations
