### **3. Reading of the Board of Cosmetology Mission Statement**

The Mission of the Nevada State Board of Cosmetology is to protect the public health, safety and welfare through education, and insuring only qualified persons are granted licenses to perform cosmetology in the State of Nevada and that all areas where cosmetology services are provided are kept clean, sanitary and safe.  
( NRS 644 & NAC 644)

### **4. Comments by General Public**

- 5. Review and possibly formulate revisions for submission to the legislature to NRS 644.207.** The number of hours to receive an esthetician's license is excessive in relation to other states within the United States. It is proposed to lower the number of hours from 900 to 600 for an esthetician and from 1,800 to 1,200 for an esthetician's apprentice.

*The committee agreed to propose a reduction in the total curriculum hours requirement for an esthetics license from 900 hours to 600 hours. This reduction would also reflect the total hours requirement for an esthetician apprentice from 1800 hours to 1200 hours.*

- 6. Review and possibly formulate revisions for submission to the legislature to NRS 644.205.** The number of hours to receive a nail technologist's license is excessive in relation to other states within the United States. It is proposed to lower the number of hours from 600 to 400 for a nail technologist and from 1,200 to 800 for a nail technologist's apprentice.

*The committee agreed to propose a reduction in the total curriculum hours requirement for an esthetics license from 600 hours to 400 hours. This reduction would also reflect the total hours requirement for an esthetician apprentice from 1200 hours to 800 hours.*

- 7. Review and possibly formulate for submission to the legislature to add a new license to NRS 644 for a Waxing Technician**

The proposed license would require a 75 hour curriculum which could be taught in a wax technology course.

*The committee decided against introducing a new license for a Waxing Technician.*
