 - The hybrid education subcommittee to review a list of services and skills that cosmetology students must complete prior to testing for their cosmetology licenses. The hybrid education subcommittee will identify which services may safely be performed remotely and which services should be performed in the school's physical classroom. The final list of approved remote services will be brought before the full Board for review and vote.
